Introduction

BOOKS ABROAD was founded as LINK in 1982 and was originally based in a cupboard in the Brander Library, Huntly. Some time after, the North East of Scotland Library Service granted LINK the use of space in the former caretaker's flat in the same building. The increased space permitted the development of proper storage and selection systems for donated books. In 1991 Gordon District Council (now Aberdeenshire Council) kindly gave us the use of a suite of offices in Rhynie, allowing further expansion to our service. The name LINK was changed to BOOKS ABROAD at this time. In 2002, courtesy of a Landfill Tax Credit Award Grant, we took over the factory unit (Unit 1) attached to the office. This provided the opportunity to greatly enhance our output which now runs at some 200,000 books per annum. In April 2011 we took over the adjoining warehouse (Unit 2) and this is now utilized for receiving and sorting book donations prior to them being shelved in Unit 1 ready for selection. This now gives us 582 square metres of warehouse space and 107 square metres of office accommodation.

Book donations are received from schools, colleges, universities, libraries, Aberdeenshire Library Information Services, book publishers, individuals and other organisations throughout Scotland and some parts of England. We operate a collection service although some book donations are brought to us in Rhynie by the donors. Our collection service extends only as far as the Central Belt of Scotland. We currently have drop-off points in Glasgow, Edinburgh, Dundee and Aberdeen provided by BSS, who are distributors of pipeline, heating and mechanical services equipment.

BOOKS ABROAD send carefully selected book parcels weighing approximately 8.5 kgs each (40-50 books on average) directly to educational establishments overseas. The parcels are wrapped in clear polythene which speeds passage through customs. We are demand driven, providing only the types of books requested by the recipients. Emphasis is upon quality, good condition books rather than quantity. Parcel sizes have been optimised to ensure that they can be carried to the most remote sites even where there is no road infrastructure. BOOKS ABROAD meet all transportation costs with no cost to be borne by the recipients.

Strenuous efforts are made to satisfy all bona fide requests received. If we cannot satisfy demand from our stock of used books, then we purchase new books as funds permit e.g. readers, grammar, dictionaries, atlases and health books.

More recently, we have been expanding our Special Project Activities by sending quantities of books in 20ft containers to larger institutions such as Universities and sending pallets of books to smaller projects such as libraries or community youth organisations. Whenever possible we utilize the Partnerships/Alliances we have built-up over the years to assist with the distribution process within each country, thus minimising our distribution costs.

The majority of our funding is provided by Trusts and Foundations with the remainder coming from Memberships, Donations and, increasingly, Fundraising Events. We are extremely grateful to all our benefactors for their support.

All works are carried out by our team of extremely dedicated volunteers, supported by two paid office staff and a fundraiser who is remunerated on a commission basis.

Mission Statement

BOOKS ABROAD promotes literacy, education and understanding, which provide the means of a sustainable escape route from the plight of poverty. We recycle used books by sending them to schools and other institutions in developing countries. We should aspire to meet the worldwide demand for recycled books, whilst maintaining a quality level of service.

Reference and Administrative Details

BOOKS ABROAD is a charitable organisation which operates without financial gain accruing to its Members. Our primary objectives are to promote literacy, education and understanding regardless of the political or religious beliefs of those who require our help.

BOOKS ABROAD is registered as a charity with the Office of the Scottish Charity Regulator and accepted as a charity by the Inland Revenue.

Chairperson's Report

Looking back over 2011 I am pleased to report a very good year for Books abroad.

My years at BA confirmed my views on the dedication and commitment of everybody connected with BA. This year we celebrate the 30th year of service during which time nearly 3 million books have been sent worldwide - a remarkable achievement.

Books Abroad has made great strides in the governance of the organisation with a clear strategy and budgets. The despatches have gone up and the distribution is much wider on a year-to-year basis. We are now in receipt of greater and in-depth feedback to ensure that we are making a difference.

On the training front both the trustees and the volunteers receive an ongoing training and these sessions are well attended. We now have a clear Health and Safety Policy and procedure.

We have made tremendous progress with partnership working with Charities based abroad. The successful "Mission to Mombasa" trip the previous year not only raised funds for the charity it also gave us an opportunity to see the distribution of books to over 38 organisations and we received very valuable feedback. This link has resulted in an application to Western Union in America for funds to carry out further projects in Africa. The "Voyage of Discovery" trip to Nepal this year not only helped raised funds but also provided very valuable insight into requirements and the logistics of transportation.

INNOVATIVE APPROACH. A container load of books was sent to Zanzibar and over 80 schools were able to receive books as per their requirement. This took place in November 2011 and, within two weeks, over 53,500 books were distributed with local help. We are constantly looking to reduce despatch costs and to ensure that books reach their intended destinations. During 2011 we have linked with the Minister of Education in Rwanda to help distribute books locally and in 2012 we are collaborating with the Mara Foundation in Uganda.

Looking ahead with improvement in our financial position we intend to plan for the longer term and special emphasis will be placed on increasing our reserve funds in the coming year. We will continue to offer both the bespoke service to remote part of the world via our small parcel service and work with our partners to maximise impact and reduce costs.

I take this opportunity to thank everybody for your continued support.

Report of The Trustees for the year ended December 31st 2011

The Trustees (Members of the Management Committee) of BOOKS ABROAD are pleased to present their Annual Report and Financial Statements for the year ended 31st December 2011.

Structure, Governance and Management

BOOKS ABROAD operates as a charity governed by its Constitution and Rules (last revised June 2009), and is administered by a board of Trustees (Management Committee) consisting of four Office Bearers (Chairperson, Vice-Chairperson, Secretary and Treasurer) and no more than eight other members. Management Committee meetings are held monthly with a minimum of five members forming a quorum at such meetings.

Trustees are required to be Members of the charity and are elected at the AGM for a period of three years. Three Trustees shall retire annually and be eligible for re-election at the end of their term of office. New Trustees may be co-opted on a temporary basis, until an AGM is held, at which time, they must be formally elected. The induction of new Trustees is facilitated in-house.

In terms of organisational structure, the Trustees have delegated the day to day management of BOOKS ABROAD to staff members. However, ultimate responsibility for decision making rests with the Trustees. The General Manager and Development Officer attend the monthly Management Committee meetings to allow regular information sharing and the discussion of issues where guidance and/or a decision is required.

Whilst BOOKS ABROAD is an independent charity, a strong emphasis is placed on strategic Alliances/Partnerships to enable us to pursue our charitable objectives more effectively. Examples of such Alliances during 2011 being our work with Zanzibar Library Services and the Rwanda Scotland Alliance.

There is on-going assessment by the Trustees of all major risks to which the charity may be exposed. BOOKS ABROAD considers Health and Safety a priority due to the nature of the operations undertaken, with risk assessment, relevant safeguards and mandatory training in place together with adequate business insurance cover. All equipment (i.e. electrics, forklift, fire prevention) is regularly maintained and tested by appropriate examiners. Segregation of duties is in place as far as is practical to safeguard the charity's assets (equipment, books and incoming funds). Our risk assessment policies and procedures are subject to continuous review and revision.

Objectives, Activities and Achievements

Objectives and Planning

In general terms, the objectives of the charity are to promote and maintain literacy and education in all its branches and at all levels, by any lawful means, in any area of the world where lack of resources would otherwise be an obstacle to its achievement. Book assistance is offered regardless of the political or religious beliefs of those who require help. In order to achieve these objectives, BOOKS ABROAD will aim to re-use, wherever possible, good quality second-hand books and other educational materials received as donations, in order that such materials may have a second life in the hands of the charity's beneficiaries overseas. An integral part of our mission as a charity is that the books are delivered door-to-door, wherever possible, in order that the beneficiaries bear no financial burden.

More specifically, BOOKS ABROAD operate a three year planning cycle, with the objective of providing assistance to all of the educational establishments registered on our database at least once in the three year cycle. The Three Year Plan is prepared in advance and sets out the key objectives to be addressed during the period and a Country Despatch Plan giving the year in which each country will next be addressed.

A detailed Despatch Programme (including Special Projects) and Financial Budget are prepared prior to the commencement of each Financial Year. The Despatch Programme and Budget are carefully monitored throughout the course of the year and "flexed", as necessary, taking account of political situations, natural disasters, shipping circumstances and funding availability.

Historically, the Charity's annual output has been between 35 and 40 tonnes, and is achievable in terms of available book resources and 'manpower'. The main threats to maintaining these output levels are the reduced incoming funds (a continuing legacy of the 2008 banking crisis) and the ever-increasing costs of transportation, particularly from port to door in the receiving countries.

Despatch Programmes comprise both the regular book parcels sent to schools and a number of Special Projects which are identified each year. Instead of small book parcels, Special Projects, usually libraries or other community groups, receive larger consignments of carefully chosen boxed books, ranging in size from one pallet-load to a complete 20ft shipping container depending on the nature and size of the project. The aim is to send two full containers per year (one every 6 months) as part of the annual despatch.

Despatch

Total book despatches during 2011 amounted to 36,098 kgs (2010 – 25,768 kgs). This is equivalent to 189,000 books (2010 – 130,000 books). Despatches were worldwide to 234 client organisations in some 33 different countries (2010 – 143 clients in 27 countries). In total, Books Abroad have now dispatched some 2,607,000 books (519.8 tonnes) to our clients worldwide.

Despatches during 2011 were according to our despatch plan for the year and were significantly up on 2010 (which was adversely affected by the extreme weather conditions during the periods January to March and November/December when the warehouse in Rhynie was effectively "snowed in"). The achievement of meeting our despatch plan in 2011 was a tremendous achievement when one takes into account the disruption caused by the absorbtion of the additional warehouse space during the year. The Trustees recognize the supreme effort of the volunteers during the year coping with the changes and achieving the despatch targets.

The Zanzibar Schools Project is one example of the innovative approach we now try to adopt when dealing with projects. Rather than selecting and packaging books for each of the eighty schools, which is hugely time consuming and very expensive to ship, we effectively sent a "mini-warehouse" of books in a 20 foot container. We consolidated the "statement of needs" for each of the schools to give the total needs for the project and "stocked" the "mini-warehouse" accordingly. The container was dispatched to Zanzibar Library Services who provided us with sufficient floorspace to put all the books on display. The schools were then invited to come to the Library and select the books they required. This was only possible as Zanzibar is relatively small and no school had far to travel to the Library. As this was the first time we had attempted this type of distribution, and to ensure proper control procedures were in place, a representative of Books Abroad was sent to Zanzibar to oversee the process. The 53,500 books were successfully distributed to the eighty schools during a two week period in November 2011.

This Project was highly successful allowing us to verify that all eighty schools received books of their choice from the books sent. It was also extremely cost efficient and resulted in dispatch/distribution costs being some £12,000 less than our traditional methods. There were also significant savings in volunteer time in Rhynie due to the alternative method of selection and packaging with a resultant saving on overhead costs.

Client Feedback

Upon delivery, schools are requested to acknowledge receipt of their parcels and asked to complete and return the Green Feedback Forms, which are enclosed within each parcel, as soon as they have had time to assess the usefulness of the books. This allows us to monitor deliveries and assess the relevance of books sent. Schools are now contacted six months after the dispatch date if no acknowledgement or feedback has been received. As a consequence, feedback assessment can only be performed for the year prior to the accounting year in question.

For 2010 despatches, 69% of clients, accounting for 85% of the books sent, acknowledged receipt of and/or returned the feedback forms (2009 - 55% and 78% respectively). This response rate is significantly better than previous years (2009 - 55% of clients; 2008 - 46%; 2007 - 44%). This continued improvement is a direct result of the more robust approach taken to ensure clients comply with our Terms & Conditions. The Trustees are pleased that the response levels continue to improve and anticipate further improvement for 2011 despatches as the new approach takes full effect.

Charity Statistics

Volunteers

BOOKS ABROAD is dependant on volunteers, and their significant contribution is valued enormously. Almost all aspects of the selection and packaging processes are undertaken by volunteers. A significant number of our volunteer selectors are retired teachers which enhances our ability to select appropriate books specifically for each educational establishment. Five of our volunteers are also actively involved in the governance of BOOKS ABROAD, being Trustees.

BOOKS ABROAD has always been a volunteer based charity with the commitment of the volunteer-base long-standing. The majority of volunteers help regularly with some having done so for over 20 years. Of the 34 volunteers at the end of 2010, seven ceased to be involved during 2011 and eight new volunteers commenced during the course of 2011 giving volunteer numbers of 35 at the end of 2011.

There are currently two main volunteer days per week, Mondays and Wednesdays, normally between the hours of 10am - 3pm. volunteers may attend either one or both days and work whatever hours they find suitable. Some volunteers find it more suitable to work at other times and every effort is made to be flexible and accommodate such variations.

The estimated number of volunteer hours during 2011 was 4,100 hours compared with 3,500 hours in 2010. The increase in hours during 2011 is primarily due to less time being lost due to adverse weather conditions.

Charity Membership

Membership of the charity stands at 150 members at the end of 2011 of which 76 are life members (2010 – 152 members – 71 life members). The movement of 2 members consists of 9 new members less 11 memberships not renewed. During 2012 the Trustees intend to develop a strategy aimed at boosting membership numbers and income.

Book Donations

The receipt of good quality second-hand books is essential to the ongoing operations of BOOKS ABROAD. Non-educational book donations, not matching our criteria for overseas distribution, are sold in our on-site book shop or at various fundraising events.

"Drop-off" centres were established during 2010 in Glasgow, Edinburgh, Dundee and Aberdeen at the Scottish depots of The BSS Group. Donors drop their books into the depots and BSS store them and ultimately transport the books free of charge to Rhynie. During 2011 we received approx 4.6 tonnes of books via BSS (2010 approx. 1.0 tonnes).

Recycling

Books Abroad aims to rescue and re-use good quality used books that may otherwise be disposed of as waste. The books are given a second life by sending them to schools and other educational establishments in developing countries. Badly damaged books, that are unfit for this purpose, and other books considered unsuitable for sending overseas are industrially shredded which is then used locally for animal bedding or composting. During 2011 some 7.4 tonnes of books required shredding (2010 – 6.0 tonnes). This increase reflects the continuing effort to ensure only suitable, good quality books are available for selection and the excess of adult literature we continue to receive. Shredding levels are not expected to decrease during 2012 as a major exercise to purge our selection shelves of slow moving/unsuitable books is undertaken.

Office waste is shredded or recycled accordingly. Cardboard and other packaging that we are unable to effectively re-use ourselves is recycled.

Capacity Building and Change Management

Client Review

At the end of 2009 Books Abroad had 1,489 clients on the old database. A Client Review was necessary for the following reasons:

- Too many Clients to service on a three year cycle.
- Many of the existing clients failed to comply with our Terms & Conditions, particularly feedback.
- No successful communication between Client and Books Abroad in recent times.
- To check data integrity before transfer to the New Database.

The results of the review were as follows:

The review highlighted that only 22% of the clients on the old database were contactable and fully compliant with our Terms & Conditions. These Clients were retained and their information transferred to the New Database with the records of the other 78% of Clients, who were non-compliant on not contactable, being archived.

Client Database

The new Client Database was designed and built during 2010. Populating the database was managed in conjunction with the Client Review. Only information relating to existing clients fulfilling the review criteria was migrated to the new database. New Clients were added on an ongoing basis.

At the end of 2011 the database had a total population of 537 Clients of which 39 had been archived leaving 498 active clients.

New Request Database

The volume of potential new clients (new requests) increased considerably during 2010 to the extent that a New Request Database was designed, built and came into operation during August 2010. This database provides control over all the requests with a clear and transparent record of the actions and decisions taken. Only a relatively small number of New Requests can be accepted due to the number of existing clients and the output constraints (volunteers and funding) which we face.

From August to December 2010 some 188 new requests were processed of which 78 were accepted and transferred to the New Client Database, 91 were rejected with 19 pending at the end of 2010.

A further 262 new requests were received during 2011 together with the 19 carried forward from 2010 giving 281 to be dealt with. Of these 40 were accepted, 214 rejected and 27 are pending.

Warehousing

As we continue to move forward to meet the ever increasing demands for our services, we became aware of the opportunity to lease the adjoining warehouse (Unit 2) during 2011 and after careful consideration the Trustees decided that this was an opportunity that should not be missed. Particularly as we were short of working space due to the high volume of book donations received in recent years.

We took possession of Unit 2 on 1st April giving us an additional 228 square metres of floorspace. Units 1 and 2 combined now give us a total of 582 square metres of warehouse space and 107 square metres of office space.

Unit 2 is used to receive and sort all book donations. The sorted books are then put on to the selectors' shelves in Unit 1. Pallet racking has been installed in Unit 2 to store pallets of sorted books which are not needed immediately on the selectors' shelves.

Unit 1 is used for selecting, listing, parceling, projects and despatch. Some 160 linear metres of additional shelving has been installed vastly increasing the capacity of the selectors shelving. A major exercise will be undertaken in 2012 to rationalise the layout of the shelving and provide shelving for book categories which had no specific shelving before.

We are already enjoying the benefits of the additional space with efficiency having risen considerably during the course of the year. Output per volunteer hour has increased from 7.4 kg/hour in 2010 to 8.8 kg/hour in 2011.

Financial Report

Despite the continued depressed economic climate, 2011 has been a hugely successful year for Books Abroad. The Despatch Plan for the year was fully achieved with despatches being 2% greater than planned. Income was 4% above even our most optimistic thoughts with Expenditure being some 8% below budget. A tremendous performance which saw our Reserves increase by £12,349 during the year.

The financial position of Books Abroad remains in accordance with our reserves policy with Free Reserves of £43,776 (2010 - £32,071) at the Balance Sheet date. This represents over 4 months of our total forecast expenditure for 2012 or in excess of 8 months of our forecast fixed costs. Books Abroad's reserves policy is reviewed annually and is currently to maintain free reserves of not less than 6 months of annual fixed costs.

Total Incoming Resources for the year amounted to £114,975 (2010 - £74,605). This increase is almost exclusively due to a rise of £36,225 in Donations from Trust Funds with Gift Aid contributing a further £3,441.

Total Resources Expended for the year amounted to £102,626 (2010 - £82,150). The increased expenditure is mainly due to book despatches (£12k) which returned to normal after the reduced output in 2010 due to adverse weather conditions. Property Rental and associated costs accounted for £7k of the increase reflecting the addition of Unit 2 during the year.

Total income exceeded expenditure by £12,349 during the year (2010 – expenditure exceeded income by £7,545). This together with an increase in amounts payable to creditors of £10,817 are the main reasons our cash and bank balances have increased by £25,303 to £64,004 at the Balance Sheet date.

The Trustees expect the adverse economic climate to continue throughout 2012 and this will continue to bring challenges. The Trustees are confident that these challenges will be overcome and that Books Abroad will continue to at least maintain current output levels.

Future Plans

Planned Despatches for 2012

We plan to despatch 36 tonnes of books to some 175 clients in 25 countries worldwide during 2012.

School Parcels account for 9.5 tonnes of this total with parcels planned for 140 clients in 19 different countries as follows:

Africa: Gambia, Ghana, Kenya, Lesotho, Morocco, Sierra Leone, Zambia.

Asia: China, India, Kyrgyzstan, Mongolia.

Eastern Europe: Belarus, Slovakia, Ukraine.

South/Central America: Belize, Guyana.

Indian Ocean: Mauritius.

Other Areas: Grenada, Papua New Guinea.

Special Projects accounts for the remaining 26.5 tonnes as follows:

Uganda

In alliance with the Mara Foundation in Kampala. A project to send a container of educational books to Kampala where the Mara Foundation will distribute them to pre-selected schools, colleges, universities and libraries.

Kenya

In alliance with the Diamond Trust Bank in Nairobi and Western Union. Another exciting project to send a container of carefully selected books for distribution by the Diamond Trust Bank to schools throughout Kenya.

or

India

In alliance with the Rotary Clubs in India. A project to send pre-selected primary, secondary and tertiary educational books for distribution to pre-selected organizations.

Small Projects

We have identified a number of smaller projects in various countries worldwide (including Ethiopia, Ghana, and Uganda). These projects will receive one or two pallets of books each.

Independent Examiner

The Trustees intend to ask SBP to undertake the independent examination for the year ending 31st December 2012.

Notes to the Accounts

1. Accounting Policies

In preparing the accounts the following accounting policies have been complied with:

- a) The accounts have been prepared on the historic cost convention.
- b) The accounts are in accordance with applicable accounting standards, the Charities SORP 2005 (Accounting and Reporting by Charities) and comply with the Charities and Trustee Investment (Scotland) Act 2005 and Charities Accounts (Scotland) Regulations 2006.
- c) Incoming resources are recorded in the accounts when receivable.
- d) Resources expended are included in the accounts on an accrual basis. Irrecoverable VAT is charged to the Statement of Financial Affairs (SOFA) on the same basis as the costs to which it relates. Most expenditure has been directly allocated to the activities appearing in the Statement of Financial Affairs (SOFA). Property rental, insurance, water rates and electricity have been allocated between activities and support on the basis of floor area occupied. Support costs have been allocated on the basis of management estimation of activity.
- e) Assets costing more than £100 are capitalized and all tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost on a straight-line basis over their expected useful lives as follows:
